TERMS & CONDITIONS FOR DOMESTIC HIRES.

DELIVERY & COLLECTION

We will drop off and set up between approx (Depending on distance and amount of bookings for that day) 8.00 am and 11.30 am.

Collection will be after 7.00 pm (earlier in winter months).

We cannot guarantee delivery or collection at a particular time you are responsible for the unit until it is collected.

We will require a clear side or rear entry to site on flat grass. We will not deliver if there are any sharp objects or dog mess in site area.

If grass is not available we do need to know in advance so that ground sheets will be used, however we must have a place to secure the unit to.

The decision on site suitability is the delivery drivers and is final.

If the site is not suitable or we cannot gain entry or contact you for delivery purposes you will still be liable for the full booking fee.

We will require access to a 220v powerpoint within reasonable distance of the site (extension leads are provided)

Do not move an inflatable once it has been erected.

Please advise of any steps/obstacles etc when ordering as these units are heavy and will require two deliverers.

BOOKING/DEPOSITS

Please book as far in advance as possible as there is a high demand at certain times of the year. Bookings are accepted entirely at our discretion.

A Deposit of E25.00 (non refundable) when booking will secure your date and preferred unit.

The remainder should be paid on delivery. Cash cheque or credit card.

We will require E250 cash deposit on hires that involve licensed premises,

weddings etc.

In the event that the unit you have booked becomes unavailable due to damage

or other reason we will replace it with a unit of equal value or better depending on availability. We will inform you in advance if this happens.

We advise that children are not told about the inflatable until nearer the

hire time to avoid any possible disappointment due to bad weather, we do not

in strong winds etc as units can become dangerous.

In this case at our discretion we can rearrange a new date or you will be entitled

to a full refund, whichever is preferred.

INSURANCE

Our Public Liability only covers faults on inflatable or negligence on our part due to the unit not being erected correctly. Hirer is responsible for

all injuries however caused so Adult supervision is paramount. You will be required to read and sign the delivery note including Correct Use

of Equipment Advice on delivery.

The insurance does not cover you for any cleaning or damage, the hirer will be charged for this so inspection before we leave is important.

DAMAGE TO INFLATABLE

Normal wear & tear is expected and accepted as such however any damage to

the unit that occurs due to your negligence or otherwise will be charged at  
cost. Please do not allow food or drink to be consumed on the unit, also  
facepaint and silly string are not allowed. Do not allow water to be poured onto the  
unit as it can make it slippy and therefore dangerous. Keep B-B-Q's fires etc  
well away from the unit.  
dirty We reserve the right to charge extra for cleaning if the unit is left in a  
condition.

CASTLE/GARDEN SIZING

You should allow 1 metre extra space to sides and 1.7 metre to rear to  
accommodate blower unit. This will eliminate damage from fences/trees etc.
